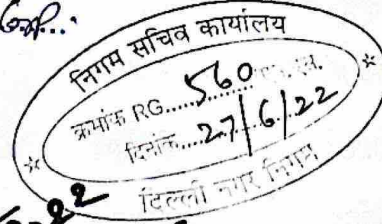

Subject: **Rationalization/Revision of Health Trade License Fee**

1. Public Health Department is regulating the health trades under section 417/420/421/422 of DMC Act, 1957. The health trade license are granted in commercial areas/conforming areas, notified commercial and mixed land use streets and residential areas as per provision of MPD 2021, and under Delhi special provision Act as per bye-laws, subject to fulfillment of the technical instructions of the trades.
2. As all three Corporations were charging different license fee for the trades in their respective jurisdictions. It is imperative to rationalize license fee after unification. Before trifurcation of MCD health trade license fee was revised in the Year, 2001 (Annexure-A). After trifurcation erstwhile North DMC has not revised Health trades license fee and continued with 2001 rates. Erstwhile East DMC revised health trade license fee in year 2013 (Annexure-B). Erstwhile South DMC revised health trade license fee twice in the year 2015 and 2019 respectively (Annexure-C). Since all three erstwhile Corporations were charging different fee before unification a detailed comparative chart of fee charged by different Corporations is placed as Annexure-D.
3. A meeting was held under the Chairmanship of Addl. Commissioner (Public Health) in which all three MHOs and Addl. MHO participated and after a detailed discussion license fees has been rationalized.
4. It is proposed that license fee and registration charges for the unified MCD may be approved as under:

5. Processing fee of Rs.1000/- will be charged per application. De-sealing charges will be three times of annual license fee. For renewal no late fee will be charged till one month from date of expiry of validity thereafter a penalty equivalent to 10 percent of annual license fee will be charged per month. Annual license fee will increase 15 percent every 3rd year.
6. The proposal for revised / rationalized license and registration charges for health Trades along with other charges like processing, de-sealing etc. as proposed in Para-4 & 5 above may kindly be placed before Special Officer, MCD exercising the powers of Corporation/Standing Committee under section 514(a) of DMC Act, 1957 (as amended in 2022) for approval Please.
