- 20. I hereby confirm that I will install number of Metal Detectors (with proper Annual Maintenance) at strategic locations for proper security. (This will be applicable to Lodging Establishments, Malls, Cineplex and building with multiple establishments).
- 21. I hereby confirm that I will install Nos. high quality CCTV cameras at strategic locations in my premises, with 30-days recording capacity.
- 22. That I will keep the license prominently displayed in my establishment at all times and on demand will produce the same to the officer/representative of local bodies, Police or any licensing authority.
- 23. I undertake to carry out periodic Mock Drills related to Disaster Management including Public Security and Fire safety in co-ordination with concerned agencies.(If required)
- 24. That there has been no change in basic structure, capacity, name and legal occupancy/tenancy and nature of the establishment since last grant/renewal of the license. (**Not applicable for performance license**)
- 25. That there is no change in facts and figures submitted during application for grant of Consent to operate under the Water Act, 1974 and the Air Act, 1981 from DPCC, (if any). I have complied with all terms and conditions specified in the previous Consent to Operate. That in the event of any information furnished found to be false OR in case of failure to comply with any of the consent conditions, renewal of consent granted against this application shall be deemed to be revoked without any notice and necessary action as per law shall be taken, which may include closure of my unit and prosecution for wrong declaration. - 26. I undertake to ensure that there is no obstruction and congestion in over all flow of traffic during the event.
- 27. That the permission for use of the venue for the performance/event/mela has been obtained from the land owning agency/owners of the premises/venue.
- 28. That no infringement of any copy right shall take place under "The Copy Right Act, 1957" and that I/we shall be wholly responsible in the event of any infringement or contravention of any of the provisions of "The Copy Right Act, 1957."

- 29. That I shall abide by all the instructions of the Licensing Authority as may be given to me from time to time in public interest, and abide by all the safety conditions prescribed for structures in the Regulations for Licensing and Controlling Places for Public Amusement, (other than Cinemas) and performance for public amusement, 1980, or any statutory agency or statute in force.
- 30. That I shall abide by the directions contained in D.D.M.A. order issued time to time and Standard Operating Procedure, as per directions of MHA GOI guidelines issued, on social/religious/sports/entertainment/educational/cultural gathering etc issued by D.D.M.A. and SOP issued time to time can be downloaded from the website of licensing unit i.e.www.delhipolicelicensing.gov.in
- 31. That I shall abide by the guidelines issued by Central Pollution Control Board dated 12.05.2020 in respect of immersion of idols.
- 32. That I shall abide by the following rules/regulations of sound levels:
 - (i) For all Public Amusement Performances being held, the level of sound to be played will be as per the Provisions of The Noise Pollution (Regulation & Control) Rules, 2000 and/or guidelines issued by any lawful competent authority from time to time.
 - (ii)The sound level at the boundary of the licensed premises, where loudspeaker or public address system or any other sound source is being used shall not exceed 10 dB (A) above the ambient noise standards for the area or 75 dB(A) whichever is lower.
 - (iii) The timing for Public Performance at temporary/open Places of Public Amusement shall be up to 10.00 PM as per the Provisions of Noise Pollution (Regulation & Control) Rules, 2000.
 - (iv) The timings for Public Amusement Performance and playing of music and other amplifying instruments during such public performance on special religious/festive/cultural occasions of a limited duration not exceeding 15 days in all during a calendar year can be increased beyond the normal timings by a special order passed in this regard on each occasion by the Hon'ble LG, Delhi.
 - (v) The timing for performances in all the Eating houses and Places of public entertainment which have license for permanent place of amusement will be as per the operational timings prescribed in the respective Registration Certificate/License for such Eating house or places for public entertainment in the respective regulations.
- 33. That I and the organizer or authorized nominees undertake to ensure that no public amusement performance is held unless necessary public performance license has been obtained from the competent authority. It shall be our collective responsibility to ensure that all the terms and conditions of the license are complied within letter and spirit during the performance. In case of violation of any term & condition or rule/regulation, I and the organizer shall be jointly liable for legal consequences arising out as per relevant provisions of Law.
- 34. That the above performance/event does not have:
 - (a) Any profanity or impropriety of language.
 - (b) Any indecency of dress, dance, movement or gesture.
 - (c) Any offensive personation or representation of any individuals.
 - (d) Anything calculated or likely to excite feeling of sedition or political discontent.

- (e) Anything calculated or likely to cause riot or breach of peace, or to promote or excite hostile feelings between different classes, or to wound the religious feelings of any individual or class of individuals.
- (f) Any dangerous exhibition or display of a performance or game with wild beasts, except in so far as it is an item of performance in a circus which shall be governed by regulations (applicable for circuses) of these regulations.
- (g) Any performance or game involving risk, damage or danger to the audience or public.
- (h) Any speech, ceremony or any other item not covered expressly by the terms of the performance license.
- (i) Any game of chance/gambling.
